Thank you for your interest in running for Director of the South Suburban Park and Recreation District Board (“Board”).

The Board is comprised of five (5) Directors, elected at large by electors of the District, on a non-partisan basis. Colorado law limits District Director terms to two (2) consecutive four-year terms. Candidates must be an eligible voter of the District at the time of signing the Self Nomination and Acceptance form (a copy of which is included in this packet). An eligible elector is a person who is: (i) registered to vote in Colorado; and (ii) a resident of the District, a property owner in the District, or the spouse or civil union partner of a property owner in the District.

Time Commitment

If elected, your probable time commitment will be as follows:

- **Regular Board meetings.** Scheduled for the second Wednesday of each month, beginning with a study session at 6:00 P.M. and followed by the regular meeting at 7:00 P.M., South Suburban Sports Complex, 4810 E. County Line Road, Littleton, Colorado. Attached is the 2025 regular meeting schedule.
- **Special Board meetings.** Held as needed. Past special meetings have been held for retreats to develop the annual budget and long-term plans.
- In addition to Regular and Special Board meetings, Directors will likely join special committees and task forces in the community; attend celebratory events, such as park and facility dedications; and participate in educational opportunities, which may require travel.

Compensation

Directors are compensated at the rate of \$100 per Board meeting or work session attended, up to a maximum of \$2,400 per year.

Election

The election date is Tuesday, May 6, 2025 and will be held as a polling place election. Three (3) Board positions will be voted upon at the election, each to serve a four (4)-year term. No other questions will be on the ballot.

Candidate Filings

In order to become a candidate for Director on the regular election ballot, the DEO must receive a completed Self-Nomination and Acceptance form by the close of business (4:00 P.M.) February 28, 2025.

To be a valid **write-in candidate**, the DEO must receive an Affidavit of Write-In Candidate on or before the close of business (4:00 P.M.) March 3, 2025. Please be aware write-in candidates will not be listed on the ballot.

Absentee Voting

Colorado special districts must meet certain legal requirements directing the conduct of their elections, different from other Colorado and national government elections. The District will not be mailing ballots to all potential voters; however a voter may request an absentee ballot. An Application for Absentee Ballot, which includes the option to request permanent absentee voter status with the District, is now available on the District's website (www.ssprd.org/elections). A copy of the Application for Absentee Ballot is also included in this packet. Voters may obtain an Application for Absentee Ballot at the District's administrative offices at 4810 E. County Line Road, Littleton, CO 80126, Monday through Friday, 8:00 a.m.–4:00 p.m.; or by calling or emailing the DEO at 303.483.7011 / Elections@ssprd.org. The deadline to request an Absentee Ballot Application is Tuesday, April 28, 2025. Completed applications should be returned to the DEO in person or by mail to 4810 E. County Line Road, Littleton, CO 80126); or emailed (Elections@ssprd.org). Please note – the application must be signed in person. The DEO cannot accept an electronic signature. Please feel free to encourage voters to contact our office with questions regarding absentee voting.

The District is required to send ballots to all Uniformed Overseas Citizens Absentee Voting Act (UOCAVA) voters pursuant to state statute. UOCAVA ballots will be sent out on March 24, 2025.

Fair Campaign Practices Act

Candidates are subject to the Colorado Fair Campaign Practices Act (also known as FCPA). A full and searchable copy of the FCPA (C.R.S., Title 1, Article 45) is available online. It is recommended each candidate take the steps with their legal counsel and become familiar with the responsibilities of a candidate under FCPA and all State election laws. On or before March 7, 2025, the DEO will file copies of Self-Nomination and Acceptance and Affidavits to be Write-In Candidate forms with the Colorado Secretary of State. This will serve as your Candidate Affidavit under FCPA. The Secretary of State will use the email address you provide on your Self-Nomination and Acceptance form or Affidavit to be a Write-In Candidate form as their medium to contact you about matters relating to FCPA reporting.
